AUTHORISED TREATMENT FACILITIES (ATFs)

Pomili Demolizioni Speciali Srl, with headquarters in Monterotondo (Rome) and a further treatment facility in Cittaducale (Rieti), is a modern Industrial Car and Motor-cycle wrecking facility. As an ELV (End-of-Life Vehicles) collection and processing centre and a member of CAR-Confederazione Autodemolitori Riuniti (Confederation of United Car Wreckers), the Company is also an authorised PRA (Italian Vehicle Registration Agency) platform for cancellation procedures.

The Company fully complies with ELV conferment, demolition, and radiation requirements (including those provided in the ELV-U.N.R.A.E. project National Union of Foreign Vehicles). Since January 2018, it has obtained the AVEI (Electric or Hybrid Vehicle Wrecking) qualification for properly managing electric or hybrid ELVs.





FI FCTRIC AND HYBRID VEHICLE WRECKING FACILITY

In January 2018, Pomili Demolizioni Speciali Srl obtained the AVEI (Electric or Hybrid Vehicle Wrecking) qualification, guaranteeing the Company's expertise and skills for managing electric or hybrid ELVs. The acquisition of innovative expertise and competencies in the wrecking of electric and hybrid vehicles ensures the provision of specialised and competitive services to Automotive Brands. To achieve this gualification, Pomili Demolizioni Speciali Srl underwent a third-party audit assessing its ability to meet technical, operational, management and training requirements.

The AVEI certification enables the Company to:

- · Assure Automotive Brands on the correct collection, treatment and re-use of electric and hybrid vehicles by referring to their technical documentation for operations to be performed on crashed vehicles and providing information on components, materials and hazardous substances;
- Ensure a complete and professional service to its customers by keeping pace with system and component innovations resulting from the different technologies on the market and related to electric and hybrid vehicles.

With its long-standing experience in this sector, **Pomili Demolizioni Speciali Srl**'s technicians recover and restore HV components and batteries from electric and/ or hybrid vehicles, aided by specific PES/PAV (Skilled/Instructed Persons) and the PEI (Qualified person to electrical works under voltage) and supported by advanced and continuous training on the treatment of electrical and/or hybrid vehicles' components.

The AVEI gualification and ISO certifications ensure compliance with environmental regulations, CEI 11-27 regulation and the obligations provided under Legislative Decree 81/08 on Occupational Health and Safety, and the Best Practices defined by the leading Car Manufacturers.

C.A.R. PROJECT - COUNTERING WASTE CARS (CONTRO LE AUTO RIFIUTO)

On 23 October 2018, **Pomili Demolizioni Speciali Srl** launched a service to collect waste vehicles abandoned in the streets of Rome. In coordination and collaboration with local law enforcement, the Company managed to clear the city streets of

6,143 vehicles (cars/trucks/vans/motorcycles/mopeds/bikes/scooters) 2018 - 2023



Backed by this experience and the process digitisation enabled by the Caronte24. com platform, the Company launched an initiative designed to flank local administrations in removing waste vehicles from public areas and protect their land. From 2022, the Company has ratified three Agreements with the Municipality.

The Company is a point of reference for private citizens, businesses, undertakings, and Entities regarding waste management and compliance with the obligations provided by the law (keeping and filling in the loading and unloading logbook, drafting and submitting the M.U.D – Environmental Declaration Form, supplying, drafting and filling in the Waste Identification Form).



Pomili Demolizioni Speciali Srl, service centre and branch office of Li. C.S.A.– Ecologia is authorised to keep loading and unloading logbooks for special waste producers with an annual production not exceeding 20 tonnes of non-hazardous waste and 4 tonnes of hazardous waste. The latter can also fulfil their obligation to keep waste loading and unloading logbooks through relevant business associations or service companies directly emanating from them.

Pomili Demolizioni Speciali Srl can:

- enter into clear, simple and transparent agreements with all customers;
- perform services tailored to the customers' needs and requests (pick-up schedule, times, days, etc.);
- carry out waste sampling and chemical and physical analysis through licensed and certified laboratories;
- provide assistance and direct environmental advice about any waste management issue;
- rent and supply its customers with validatedcontainers/casks/tanks/dumpsters/ compactors of different sizes and volumes to store the waste to be collected.

Moreover, the Company carries out waste mediation (enrolment in the National Register of Environmental Managers - Category 8) thanks to its consolidated and longterm partnership with different waste storage/recovery/disposal facilities.

BULKY MUNICIPAL WASTE COLLECTION What is bulky waste?


Bulky waste is large municipal waste that cannot be transported by car. Bulky items include house appliances and/or discarded furniture (fridges, tables, mattresses, etc.) and WEEE (Waste Electrical and Electronic Equipment), for which door-to-door collection is impossible due to their type or size.

Our recipients:

- · door-to-door collection management for Municipalities and Public entities;
- assistance to municipal Sanitation Contracting Authorities;
- · the service only applies to households;
- Individuals not equipped with an appropriate vehicle to transport the bulky waste to waste separation and recycling areas.

The service includes the following activities:

- collection of bulky waste from the roadway once the user has placed it close to their household;
- transport and delivery of the waste above to the relevant Municipal Collection Centre;
- transport and deliver the waste above to authorised recycling/disposal facilities or MRFs (multi-reuse facilities).



SCRAPPING, TREATMENT AND STORAGE OF WASTE ELECTRICAL AND ELECTRONIC EQUIPMENT (WEEE), FERROUS AND NON-FERROUS MATERIALS

Pomili Demolizioni Speciali Srl new waste management facility is located at 3 Via Benito Graziani, in the Municipality of Cittaducale (RI) - Santa Rufina industrial area.





The Company is authorised to treat and store the following waste:

- scrapping of waste electrical and electronic equipment (WEEE) containing hazardous substances and components as listed in Annex II of Legislative Decree 49 of 14 March 2014 which only perform storage (R13) and reuse operations;
- scrapping for recovery, recycling, reuse of waste electrical and electronic equipment (WEEE) and components, as listed in Annex II of Legislative Decree 49/2014 not containing hazardous substances;
- scrapping for the recovery, recycling and reuse of non-hazardous waste (ferrous scraps), as listed under Ministerial Decree of 5 February 1998.





ASBESTOS REMOVAL AND RECLAMATION OF CONTAMINATED SITES

Pomili Demolizioni Speciali Srl, as a Company enrolled in the National Register of Environmental Managers for 9D and 10B-C categories/classes, operates across the country and provides technical, organisational and operational assistance to address several issues of civil and industrial nature, among which:

- reclamation of contaminated sites and assets, both in use and not:
- removal, reclamation and encapsulation of ACMs in a friable or compact matrix, using specific removal and disposal products;
- compact or friable ACM confinement, covering and enclosing;
- encapsulation of compact or friable ACMs;
- reclamation of asbestos-containing sites, assets and lands;
- risk and state of preservation assessment for asbestos-cement roofing according to the General Health Management Decree 13237 of 18/11/2008 accompanied by specific definition and certification of Degradation Index (DI).

By way of example, asbestos-containing materials might include:

roofing;

- smokestacks:
- downpipes;
- pipes;
- tanks:
- reservoirs:
- containers;

- chimneys;
- flooring;
- coating;
- insulation materials:
- gaskets;

- glues;
- insulating panels;

Our qualified and sector-experienced technicians ensure:

- the utmost transparency with competent bodies (Local Healthcare Authority ASL, law enforcement bodies, etc.);
- paperwork handling concerning each reclamation operation as provided by law (drafting and submission of the Work Plan to the competent ASL, Notification of Commencement of Works, Notification of Completion of Works, Work Completion Report, Reclamation Certification, Waste Identification Form (F.I.R.) proving waste disposal, various communications, etc.);
- Provision of any information, suggestion and support in drafting studies and operating specifications, as well as quality, risk analysis and safety procedures.

In addition, the Company manages generated and produced waste while also ensuring traceability and monitoring over the following stages:

- document management;
- packing;
- transport and logistics;
- conferment to recovery facilities and/or disposal through authorised plants.



DEMOLITION OF PLANTS AND BUILDINGS

Pomili Demolizioni Speciali Srl holds one of the highest engineering, organisational and managerial qualifications to carry out demolition, dismantling and strip-out operations on buildings and plants, both in use and not, of different types:

- · industrial;
- civil;
- commercial:
- road;
- naval;
- military;
- railway;
- aeronautical.

The Company - active across Italy - adopts different demolition techniques according to the surrounding environment and the type of work. More specifically, it performs:

- hot works;
- · cold working;
- · torch welding;
- works with self-propelled hydraulic shears, grapples, telescopic cranes, spider loaders and other specific demolition equipment;
- · selective and controlled works;
- disc and diamond wire cutting operations;
- above-ground works;
- manual works.

Our multidisciplinary technicians are available to provide consultancy and information, partnerships, work specifications, quality procedures and risk and safety analyses.

In addition, the Company handles the management of the waste generated and



produced during the interventions, ensuring traceability and control over all stages of classification, characterisation, analysis, document management, transport, logistics, and start-up for recovery and/or disposal in authorised plants.

Our company's organisational efficiency stands for reliability and certainty in achieving pre-established goals while at the same time guaranteeing rapid, quality, and utterly safe intervention. In addition, the Company has state-of-the-art technology and specialised and trained technical staff capable of operating on all sites under tight deadlines. All necessary prevention and protection measures for workers and the environment are granted at every demolition stage, with all environmental restoration and reconversion operations being carried out.

The Company offers the following services:

- complete dismantling, clearing and redevelopment of large industrial areas;
- · demolition of silos, tanks, chimneys, etc;
- selective dismantling, removal and emptying of interiors (furniture, furnishings, fixtures, upholstery, flooring, structures, partitions, false ceilings, masonry work, screeds, external and internal plugging, door and window frames, exposed fixtures, sanitary fixtures, various materials, etc.) involving the recovery and reuse of valuable materials and the disposal of compromised ones;
- industrial relocations, including storage services for short and long periods;
